Opening remarks and reports.

The Club Captain made a short speech basically endorsing the contents of the Chairman's report, but also hoping that the new season would enable the club to have less tension and more continuity. - c) Anyone who has not paid subs will have to pay a temporary membership of £5 for that week, to cover costs of insurance, EH membership and Club insurance.

Petrol – all players will pay full match fees, if petrol money is required it will be shared by the passengers/driver of the car.
